Branch & Limb Collection:

7 AM on MONDAY, SEPTEMBER 30TH



Please note this **IMPORTANT CHANGE** to our Branch & Limb Collection: Branches and limbs MUST be placed at your trash collection site **BY 7 AM on MONDAY, SEPTEMBER 30**TH. We will collect from each street **ONE TIME ONLY**. Any branches/limbs put

out AFTER September 30th will be YOUR responsibility to dispose of.

Limbs may be up to 6" in diameter and 4" to 6" in length. **Do not bundle.** Yard waste such as ornamental grass, garden residue, etc., will not be picked up. The Borough reserves the right to refuse items that do not meet the requirements and is not responsible for cleanup.



Fall Leaf Collection: Approx. Oct. 7 – Nov. 29

The pickup schedule is variable depending on weather conditions. We appreciate your understanding that this schedule must be flexible. Place leaves at the curb. They will not be picked up if they are placed elsewhere. Do not mix any other items with the leaves. We will get to your leaves as soon as we can. There will be no collection on Borough holidays. Leaves in plastic trash bags will not be picked up.

DO NOT place your leaves at the curb before our collection begins.

Doing this will clog our storm drains, and they MUST remain clear of debris.

IMPORTANT NOTE: The Public Works Facility cannot accept yard waste items at their location. You can take those items to the York County Solid Waste Authority's Resource Recovery Center where it will be diverted to their Yard Waste Transfer Facility, provided it is free of contaminants and meets end user requirements. Yard waste includes leaves, garden residues, shrubbery, tree trimmings that do not exceed 6' in length or 24" in diameter and tree stumps that do not exceed 24" in diameter. **NOTE:** Before doing this, visit their website at www.ycswa.com, or call them at 717-845-1066, for requirements and restrictions you will need to be aware of.







Christmas Tree Collection: January 2 - 17, 2019

The Borough will pick up discarded Christmas trees beginning Thursday, January 2. Trees should be placed at your usual trash pickup site and MUST NOT be in a bag. All decorations and tinsel must be removed.

ZONING & CODES ENFORCEMENT

From the Desk of our Zoning & Codes Enforcement Officer, Dan Shaw:

Quality of Life Ticketing Program

Red Lion Borough has implemented a Quality of Life Ticketing Program. This program is for certain property maintenance violations and is similar to the Red Lion Borough parking violation tickets. When a problem property is identified by a Red Lion Borough Code Official, a courtesy notice identifying the violation will be posted on the property. If the violation is not corrected within the time specified on the notice, a violation ticket will be issued and posted on the property or delivered to an adult resident of the property. Fines will start at \$25 for the first offense and will increase with each additional violation, up to \$300. Tickets are to be paid within ten (10) days of receipt in accordance with the instructions on the ticket. If not paid within those ten days, a citation will be issued through the district magistrate's office, which will include additional court costs. Some of the most common violations include:

- · Nuisance vehicles
- Items not for outside storage
- Grass and weeds over 6"
- · Accumulation of refuse

Snow & Ice Removal

Snow and ice must be cleared or treated on sidewalks to a width of 36" within 12 hours after the snow stops or the ice forms. If the snow stops or ice forms after 6 PM, it must be removed or treated by 6 PM the following day. A Quality of Life violation ticket will be issued without a courtesy notice. It is also unlawful to place any snow or ice into a public street or alley. The most complaints come from the school district or the parents of children who walk to school or to the bus stop.

SO PLEASE REMEMBER, OUR CHILDREN NEED A SAFE WALKING SURFACE TO SCHOOL AND BACK!

Building & Zoning Permits

Most maintenance to residential properties does not require a building or zoning permit; however, additions, structural changes or repairs, sheds, fences and walls will require a permit. Commercial properties typically require a building permit for almost all types of work. Contact the Borough Office for more information.

Sidewalk Permits

A permit is required to replace the curb and sidewalk which is along a public street. There is no fee for the permit. The applicant must pick up a copy of the specifications.

Snow Emergencies

In the event of a severe winter storm, the Mayor will declare a snow emergency. Local radio and television stations will be advised, and it will be posted on our website. You shall not park a motor vehicle or allow a vehicle to remain parked on Main Street, High Street or Broadway after a snow emergency is declared. Fines start at \$75.00 and may be assessed every eight hours.

Trash Collection

Do not place trash at the point of collection in excess of 12 hours before your collection day, which is on Friday for all residential customers. Refuse being stored for collection must be placed in a container which shall not permit blowing or scattering by wind and shall be rodent-proof, insect-proof, and watertight.



Nuisance Vehicles

The outdoor storage of any motor vehicle that is without a valid inspection certificate displayed for a period in excess of 30 days is a nuisance and must be removed or stored in a fully enclosed structure.

Tenant Registration

Landlords must register all occupants over the age of 18 within 30 days of occupancy of a residential rental unit.

Tenant Complaints

Red Lion Borough has a housing maintenance and occupancy code which deals with the maintenance of residential dwellings. If you have a complaint about your rental unit, a complaint form is available in our office.

Housing

No owner or occupant shall install, operate, or use an unvented space heater employing a flame. This would include unvented portable gas and kerosene heaters.



Tree Trimming

To avoid damage to borough equipment, personal vehicles and for the safety of everyone, trees must be kept trimmed to a height of 14' above and along the edge of the roadway and 9' above sidewalks.


AN IMPORTANT MESSAGE ABOUT STORMWATER

Stormwater 101

Unfortunately, the problems associated with stormwater aren't limited to major storms; they often result from the average rainfall event. Human activities have altered the landscape so dramatically that the natural system for stormwater management no longer works.

Consider the path rainfall takes when it hits the ground: it either soaks into the ground to become groundwater, evaporates, or flows over the surface of the land. This overland runoff—

stormwater—feeds our surface waters, but it also carries sediments, chemicals, automobile oil, trash, and other natural and not so natural debris along with it. Groundcover, trees, soil, wetlands, and a wide range of other landscape features act as buffers and barriers that slow stormwater, trap or filter out pollutants, and enable infiltration and evaporation to occur.

Nature continuously recycles the Earth's water supply through a dynamic process that has existed for millions of years. This water cycle (or hydrologic cycle) moves rainfall from the atmosphere to land, through surface and groundwater systems, to the ocean, and back into the atmosphere. The water cycle is made up of several basic components: evaporation (and transpiration), condensation, precipitation, infiltration, groundwater recharge, and runoff.

Anyone who has looked at local rivers and streams during a storm can see the effects of runoff. Soil that washes off construction sites; trash, cigarette butts, and other litter that has washed from parking lots; antifreeze and oil that has dripped from cars and trucks; fertilizers and pesticides from golf courses, fields, and lawns; nutrients from agricultural operations; grit and salt from de-icing roadways: all this and more can be flushed directly into waterways when it rains.

The more we alter the landscape, the more we affect the natural cycle and its ability to deal with runoff. When we grade and cut and pave and build, we're not only causing more polluted water to move into waterways more quickly, we're making less water available for absorption into the ground. Believe it or not, that can affect stream flow and the aquifers we depend on for drinking water in many parts of the state.

There was a time when "point source pollution" flowing into waterways from industry and sewage treatment facilities was the biggest threat to water quality. Today, non-point source pollution (such as abandoned mine drainage, atmospheric deposition, earth moving activities, on-lot septic systems, timber harvesting, and runoff from urban areas and agricultural lands) is the cause of most water quality problems across the country, including here in Pennsylvania.

In many parts of the state, stormwater overwhelms aging sewage infrastructure, causes flood damage, and puts people's health at serious risk. Unfortunately, these problems aren't limited to major storms; they often result from the average rainfall event. Human activities have altered the landscape so dramatically that the natural system of "stormwater management" no longer works.

The average annual precipitation in Pennsylvania ranges from less than 34 inches to more than 50 inches per year, with most coming during small, frequent storms. Some 65% of the state's average annual rainfall occurs in storms that drop less than 1 inch in a 24-hour period; more than 95% comes from storms of 3 inches or less. Even though Pennsylvania has been hit by several tropical storms and hurricanes over the past century—with devastating results—the large 50-year and 100-year storms occur so rarely that they account for an insignificant amount of total rainfall volume when averaged out year after year.

Dealing with rainfall from the many small storm events, while planning for the massive volume spikes that do occur during major storms, is the key to stormwater management success. Electronics Recycling

The York County Solid Waste Authority's Residential Electronics Recycling Program is free and open to York County residents ONLY and is conducted Monday through Friday from 8:00 a.m. to 4:00 p.m. and Saturdays from 8 a.m. to noon at the Small Load Drop-off Facility at the York County Resource Recovery Center. The Resource Recovery Center is located at 2651 Blackbridge Road.

Accepted items:

• Computer: Devices PC's/Laptops/Servers

• Monitors: CRT, LCDs

• Televisions: CRT, Flat Panel (LCD, Plasma, LED), Console, Projection

• Networking Devices: Servers, Routers, Switches, Hubs, Arrays

• Printing Devices: Printers, Fax Machines, Scanners, Copiers, Duplicators, Plotters, Typewriters

• Audio/Video Devices: CD/DVD/VHS/Blue-Ray Players, MP3 Players, iPods, Projectors, Stereos, Video Game Consoles, Speakers,

• Receivers: (audio, cable, satellite), Recorders, Converter Boxes, Amplifiers, Equalizers.

• Communication Devices: Cell Phones, PDA's, Telephones, Pagers, Answering

- Lab/Test & Measurement Devices
- Telecommunication Devices
- Power Supplies: UPS's (Uninterrupted Power Supplies), Surge Protectors
- Microwaves
- Peripherals: All items used in the function of these devices (I.e. keyboards, mice, speakers, pointing devices, etc.)
- Wire/Cabling: All cables, wires and power cords used in the function of these devices
- Hardware: All parts that are, or once were, part of these devices (I.e. circuit boards, hard drives, RAM, processors, power supplies, optical/floppy drives, etc.)

NOTE: PA law bans the disposal or collection of certain electronics at the curb in your regular garbage. Electronics that cannot be placed in your garbage include TV's, computers and anything that connects to a computer such as a printer, mouse, keyboard or speakers.

NOTICE TO All COMMERCIAL & INDUSTRIAL ESTABLISHMENTS IN RED LION BOROUGH:

Water Meter Upgrades

We are in the process of a major upgrade to our water meter system, including the replacement of water meters, some of which are over 20 years old. The existing meters are a mechanical type that loses accuracy after 10-14 years. The American Water Works Association suggests that all utilities accurately measure and account for all

water that they draw from the reservoir and distribute to end users, thus the change-out.

Change in DEP Regulations

Pennsylvania's Department of Environmental Protection recently finalized changes to their drinking water regulations which will require all drinking water providers in Pennsylvania, including RLMA, to add and maintain higher levels of chlorine in drinking water.

Current regulations require chlorine concentrations at every point of use (your kitchen sink, for example) to be no lower than 0.02 milligrams/liter (mg/L). The new regulations that become effective in early 2019 require chlorine concentrations at every point of use to be no lower than 0.20 mg/L, a ten-fold increase.

Infrastructure Update

All of us have read the dire reports about the state of America's infrastructure. The 2017 Report Card from the American Society of Civil Engineers gives the United States an overall grade of D+ on the current state of its infrastructure and highlights an estimated \$2 trillion, 10-year investment gap that needs to be closed to keep our country's infrastructure sound and reliable. These investment gaps are obvious when we drive over our roads, highways and bridges, but less obvious are the needs of our hidden infrastructure – the underground sewer and water systems that supply us with clean drinking water and carry and treat our wastewater. These problems are real, and many cities, suburban, and rural areas will face mounting pressure and costs to replace and upgrade these systems in the near future as systems built fifty years ago begin to fail.

However, this is not the case in Red Lion. Working cooperatively with local borough and township governments, the Red Lion Municipal Authority has consistently maintained and upgraded the drinking water treatment distribution systems and the wastewater collection system under its control. And we have been able to do this and still maintain some of the lowest water and sewer rates in Pennsylvania. Yes, there have been increases in both the water and sewer portions of your monthly bill, but these moderate increases have been used to consistently maintain the infrastructure that serves you daily.

We are also proceeding as planned with the replacement of the water meters throughout our system. Please call or email us if you have questions or comments and always feel free to attend our monthly meetings that are typically (but not always) held the fourth Wednesday of every month. Please check our website for the exact meeting date each month.

We Must Take the Next Steps to Improve Water Quality in York County's Streams

Since the passage of the Clean Water Act in 1972, tens of billions of dollars have been spent to improve water quality in Pennsylvania and throughout the United States. By any measure, this money was well spent and resulted in major improvements in water quality. Rivers and streams that forty years ago regularly caught fire and supported little aquatic life now support human recreation and diverse populations of fish, insects and plants.

This transformation was achieved by focusing on point sources of pollution – industrial and municipal facilities that discharge to steams through discreet pipes. Industries as diverse as oil and gas, pulp and paper, and pharmaceuticals installed and upgraded their wastewater treatment plants and improved their manufacturing processes to meet industry-specific end-of-pipe standards. Likewise, municipal facilities that serve primarily households, but also small businesses, have upgraded their treatment processes to the highest standards including the removal of nutrients. All these improvements were necessary and resulted in very measurable improvements in water quality.

However, that was the easy part. While the focus on point-sources was appropriate and successful, it is now time to focus on the non-point sources of pollution that are still causing many streams and rivers to not fully achieve water quality standards. This is much more difficult because these sources lack visible pipes and are everywhere including the air, our backyards, our roads and streets, agricultural operations and storm water. Non-point sources affect every stream in York County to one degree or another as well as the downstream water bodies they connect to including the Susquehanna River and the Chesapeake Bay.

For the past ten years the York County Planning Commission has led a county-wide effort to develop a comprehensive and sensible plan to address non-point sources of pollution through the York County Coalition for Clean Water. This multi-stakeholder group is working with Pennsylvania DEP to develop a plan that will allow York County to meet its assigned reductions in nutrients and sediment as required by US EPA's Chesapeake Bay plan and at the same time ensure that our local cities, townships, and boroughs follow their mandated pollution reduction requirements.

The establishment of a county-wide storm water authority is a critical and necessary part of this plan, but this will not be easy work. Programs and projects must be prioritized to ensure that limited resources are spent wisely and effectively across municipal boundaries. A county-wide issue needs a county-wide solution. We all contribute to the problem and we all need to work together to solve the problem. A county-wide storm water authority is the best way to do that.

Fruit and Vegetable Vouchers Available

The York County Area Agency on Aging, in conjunction with the Pennsylvania Department of Agriculture, is again offering the Senior Farmers Market Nutrition Program to eligible York County seniors.

This program provides \$20 in vouchers to eligible seniors to buy fresh fruit and vegetables from participating local farm markets.

York County residents are eligible to participate if they are 60 years of age or older by December 31, 2019 and have a 2019 total gross annual household income at or below \$23,107 for a single person or \$31,284 for a couple.

- All income is included when calculating total gross income.
 Proof of age and York County residency must be presented to obtain vouchers. A couple may each receive a voucher if their combined total income is within the income requirements.
- 2019 Proxy Forms are required for those eligible seniors authorizing someone else to pick up the vouchers for them. Power of Attorneys and spouses must also use a proxy form. ID for the senior and the proxy is required. The 2019 Proxy form is available at most senior centers, the York County Area Agency on Aging's office at 100 W. Market St., York City, or can be downloaded from the Forms & Documents page of the agency's website at www.ycaaa.org.
- One individual may not pick up vouchers for more than four people.
- Individuals are eligible to receive the vouchers only once per calendar year. The vouchers can be redeemed until November 30, on fruits and vegetables grown in Pennsylvania.
- Residents of nursing homes, personal care homes or any residential facility where meals are provided are not eligible to receive vouchers.

Vouchers will be distributed from 9:30 a.m. to 11:30 a.m. (unless otherwise noted) at the following York County locations, for as long as supplies last:





Veterans Services Office Hours

Every York County veteran and surviving spouse should have a conversation with an accredited service officer that has access to federal VA systems.

Don't Forget Your 2018 Property Tax/Rent Rebate Applications

Application forms for the Property Tax/Rent Rebate Program are now available for eligible Pennsylvanians to begin claiming rebates on property taxes or rent paid in 2018. The deadline to apply for a rebate is June 30.

Applicants may obtain Property Tax/Rent Rebate claim forms (PA-1000) and related information at the Department of Revenues website, www.revenue.pa.gov, or by calling 1-888-222-9190.

Applying for the rebate is free, and my Red Lion office at 100 Redco Ave., 717-244-9232, offers free assistance to fill out and file the applications. Even if you applied for a rebate last year, you must file again this year.

Legislative Updates

I regularly hold town halls and legislative breakfasts to keep residents updated on what is going on at the Capitol and state government in general. These meetings are also very useful in getting feedback from folks on what is going on in their communities and what I, as your representative in Harrisburg, can do for you. My town halls are typically announced in the newspapers and on my Facebook page, facebook.com/repsaylor. I mail invitations for legislative breakfasts, so keep an eye on your mailbox!

I held a legislative breakfast at the Great American Saloon in Red Lion in early May. We spoke about property taxes, the Educational Improvement Tax Credit (EITC) program, the possible closure of TMI and other nuclear plants, automation in today's workforce, work requirements for welfare recipients, and Second Amendment rights. We had a great crowd and good discussion.



REAL IDs Now Available to Pennsylvania Residents

A federally-accepted form of identification (whether it's a Pennsylvania REAL ID driver's license or ID card, a U.S. passport/passport card, a military ID, etc.) must be used as identification to board a commercial flight or visit a secure federal building that requires ID at the door on and after Oct. 1, 2020. There is no requirement that any resident obtain a REAL ID and PennDOT will continue to offer standard-issue driver's licenses and photo IDs.

Customers have three options for obtaining a REAL ID product: customers may order their REAL ID online if they have been preverified; they can visit any PennDOT Driver's License Center, have their documents verified and imaged, and their REAL ID product will be mailed to them within 15 business days; or they can visit one of twelve REAL ID Centers and receive their REAL ID product over-the-counter at the time of service.

When a customer gets their first REAL ID product, they will pay a one-time fee of \$30, plus a renewal fee (current renewal fee is \$30.50 for a four-year non-commercial driver's license or a photo ID). PennDOT has upgraded seven of its existing driver's license centers to allow for over-the-counter issuance of REAL ID (Williamsport, Wilkes-Barre, Rockview in Centre County, Erie, Altoona, Norristown and South 70th Street in Philadelphia) and added the following new locations, which are now open for business:

- 1025 Washington Pike, Rt. 50, Bridgeville;
- 143 S. Gulph Road, King of Prussia;
- 1101 MacArthur Road, Allentown;
- 429 North Enola Road, Enola; and
- 2090 Lincoln Highway East., Lancaster.

Planning for Emergencies

How can we prepare for the most common emergency situations that might occur in our day to day lives? We are fortunate that most common emergency situations are only inconveniences in our lives, but sometimes emergencies can threaten our property and well-being. In emergency management, the biggest threats are classified as high risk, low frequency. What kinds of emergencies are these? Hurricanes (here in PA), terrorist events, workplace violence, big earthquakes, etc. These are the events that emergency planners at federal, state, county, and even municipal EMAs try to plan for. You may have heard or even participated at nuclear plant drills for our 2 nuclear power stations in/near York County. Drills are one way that emergency planners test their EOPs, or Emergency Operation Plans. They can find out where the weaknesses exist in their plans.

On a personal level, we can have emergency plans too. Usually, this is something informal, just a "what if" thing we do in our heads when we hear of others who face emergency situations. What if we lost power for 2 days in the middle of summer? What if we became stranded on the turnpike in the middle of winter? Some simple planning and preparation can make the difference between being miserable, or simply inconvenienced. In rare cases, being prepared can have more significant consequences.

Being prepared consists of 2 major steps:

- 1. Make a plan.
- 2. Assemble some items.
- 1. Making a plan. American Red Cross offers these suggestions on making a personal emergency plan:
 - Plan for the emergencies that are most likely to happen where you live
 - Be familiar with natural disaster risks in your community.
 - Consider how you will respond to emergencies that can happen anywhere, such as home fires and floods.
 - Think about emergencies that may require your family to shelter in place (such as a winter storm), vs. emergencies that may require evacuation (such as a hurricane).

Good template for a personal emergency plan:

2. Assemble some items. Your summer car emergency kit will be different from your winter car kit. Your shelter in place home kit will be different from your evacuation kit ("go bag"). In upcoming newsletters, we will look at different items to add to different kits. For this issue, we offer a suggestion for a shelter in place home kit (3-day emergency). Start with what you have. Don't include what you know (FOR SURE) that you won't need. Add things that are personal to you that you will need. It's completely adaptable to your personal situation. Some companies sell kits. We think you can assemble your own kit more economically, and one that will be more useful to YOU.



3-Day Emergency Shelter-in-Place Kit

- Water + water purifier (such as Life Straws or Potable Aqua) (bottled water, aim for 1 gal/person/day)
- Waste disposal (5-6 gallon storage container can be used for toilet flushing -- or stash some contractor's heavy trash bags/5-gal bucket for waste disposal if flushing is not possible)
- Food (non-perishable: canned items, or multi-day, multiperson kits that have up to 10-year shelf life)
- Lighting (flashlights + battery operated lanterns; LED bulbs are most power efficient; candles are not recommended)
- Whistle
- · Dust masks
- Chargers (for phones, include cables + charged power packs)
- Basic first aid supplies
- Meds/tests (such as blood sugar testing) supplies
- Extra clothing
- Blankets for winter, battery operated fan for summer
- Crank emergency radio (bonus points for NOAA weather crank-powered radios)
- Baby food, formula and supplies (diapers, wipes, powder/ lotion)
- Antibacterial handwipes for sanitation
- · Pet food/meds
